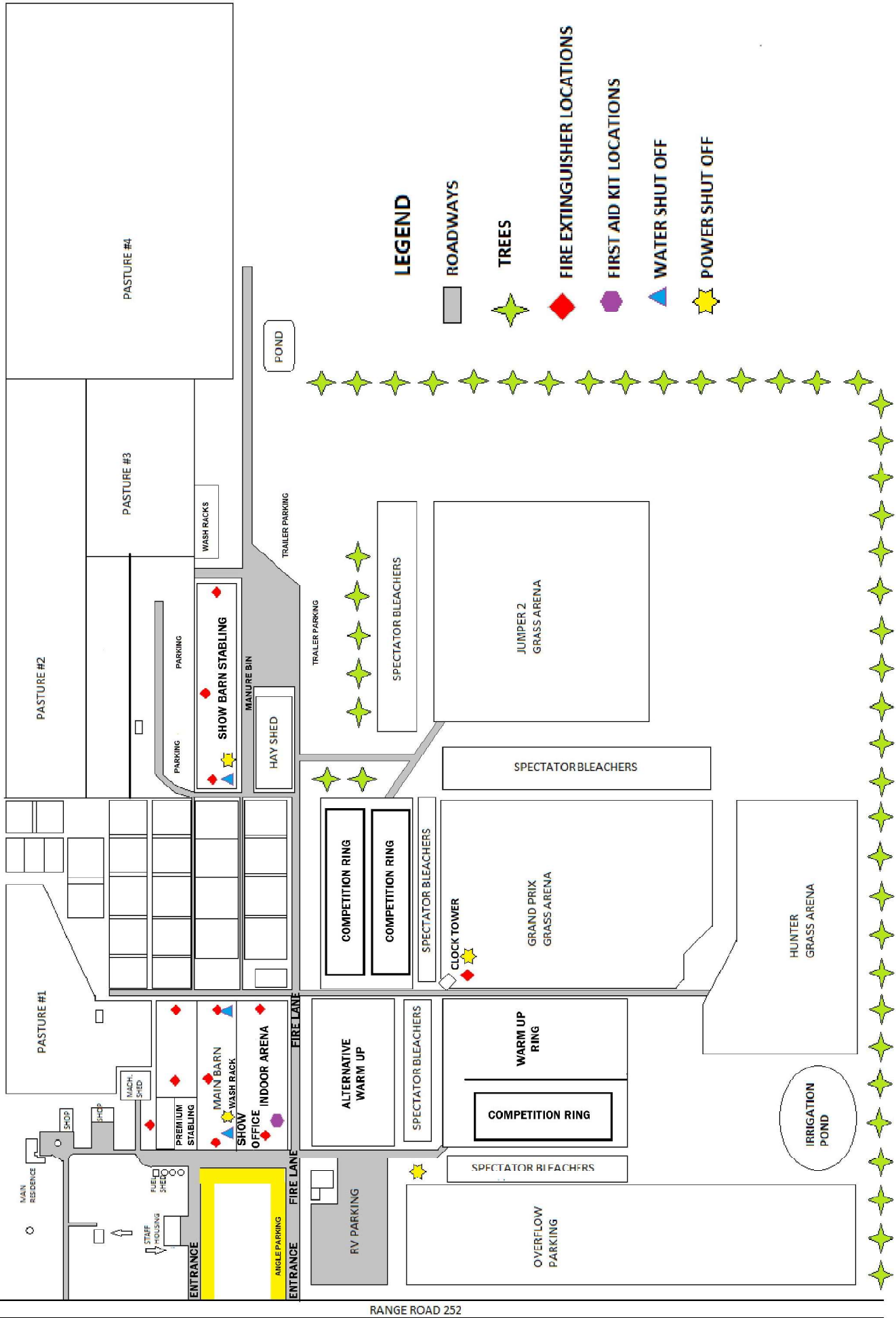

EC GOLD SHOW

EC GENERAL INFORMATION

- a) The 2025 Sparkle & Spurs EC Gold Dressage Show is sanctioned as a Gold competition member of Equestrian Canada c/o House of Sport 2451 Riverside Drive, Ottawa, Ontario, K1H 7X7 and is governed by the Rules of EC (A602.1).
- b) Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book (A602.2). It is the rider's responsibility to be familiar with the EC rules and regulations. They can be found at <https://equestrian.ca/compete/athlete-resources/rulebooks/>
- c) Per Article A801, every entry at an EC-sanctioned competition shall constitute an agreement by the person(s) responsible that the owner, lessee, trainer, manager, agent, coach, driver or rider and horse shall be subject to the EC constitution and all rules of EC and any additional rules set by the competition. (A602.7) It is the responsibility of all individuals participating in any capacity in EC-sanctioned competitions to be knowledgeable regarding the EC constitution and the applicable rules of EC and the additional rules, if any, imposed by the competition. Do not participate in this EC- sanctioned competition in any capacity if you do not consent to be bound by the constitution and rules of EC and any additional rules imposed by the competition. Note: Not all the EC Rules are listed in the prize list. As per Article A801, it is the responsibility of all to know the EC rules. Section A – General, and Section E – Dressage and Para-Dressage rulebooks can be found at <https://equestrian.ca/compete/athlete-resources/rulebooks/>
- d) EC STATEMENT OF PRINCIPLES – HORSE WELFARE (from the EC Code of Conduct and Ethics)
EC requires adherence to humane treatment of horses in all activities under its jurisdiction. All participants shall be bound by the Horse Welfare Code of Conduct. EC is committed to:
 - a) upholding the welfare of the horse, regardless of monetary value, as a primary consideration in all activities;
 - b) requiring that horses be treated with kindness, respect, and the compassion that they deserve, and that they never be subjected to maltreatment.
 - c) ensuring that owners, trainers, and exhibitors and their agents exercise appropriate care and responsibility in the handling, treatment, and transportation of their horses, as well as horses placed in their care for any purpose;
 - d) providing for the continuous wellbeing of the horse by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort, and safety;
 - e) continuing to support scientific studies on equine health and welfare;
 - f) requiring owners, trainers, and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competitions; and,
 - g) reviewing, revising, and developing competition rules and regulations that protect the welfare of the horse.

AEF WILD ROSE PROVINCIAL CIRCUIT SHOW

AEF GENERAL INFORMATION

- a) The 2025 Sparkle & Spurs AEF Wild Rose Provincial Circuit Show is sanctioned as an Alberta Equestrian Federation Wild Rose Provincial Circuit competition of Alberta Equestrian Federation and will be run in accordance to the AEF Wild Rose Competition Rulebook.
- b) Every class offered herein is covered by the rules and specifications of the current Wild Rose Competition

Rulebook and will be held and judged in accordance with the Rulebook. It is the rider's responsibility to be familiar with the AEF rules and regulations. They can be found at <https://www.albertaequestrian-events.com/competitions>

- c) Every participant at the AEF Wild Rose Competition shall agree that the owner, lessee, trainer, manager, agent, coach, driver or rider, and horse shall be subject to the constitution and rules of the competition. Not all the AEF Rules are listed in the prize list. It is the responsibility of all to know the AEF rules.
- d) The competition is required to ensure all athletes, owners, lessees and person(s) responsible for an entry hold a current AEF membership to ensure each entry is protected by their own individual liability coverage. Exceptions: Out-Of-Province competitors are not required to hold AEF membership provided they are members of their respective PTSO and are in good standing. A parent or guardian are not required to have an AEF membership if signing as the person(s) responsible for an entry that is a minor/junior competitor.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW

GENERAL INFORMATION

1. ENTRIES & SHOW OFFICE

- a. Entries must be received no later than August 6, 2025, with full payment and signed forms.
- b. There are two ways to enter the show:
 - i. Compete Easy is the show management system for the Sparkle & Spurs show. Compete Easy charges a 5.5% processing fee that will be applied to your EAADA Sparkle & Spurs entry fee. To enter, please visit: www.competeeasy.com and then go to the SHOW section. The show will be live for entries July 18, 2025.
 - ii. If you still wish to mail / email your entry in, you will be charged a mandatory processing fee. See the Fee Schedule for the cost. Scan and email your entry to showsecretary.eaada@gmail.com and pay by email bank transfer, also to showsecretary.eaada@gmail.com. The password for the email bank transfer should be set to dressage.
- c. If there are any questions about entries, please email showsecretary.eaada@gmail.com.
- d. Late entries may only be accepted at the Organizing Committee's discretion with a late fee as set out in the Fee Schedule.
- e. Entries may be limited and will be processed in the order that they are received. The Organizing Committee reserves the right to refuse entries (See Article A805 – Refusal or Limitation of Entries)
- f. Incomplete entries will not be processed until they are complete. All entries must include payment in full, all release signatures and copies of vaccination certificate.
- g. All entries must have the signature of the owner or authorized agent and the signature of the person responsible for the horse. Riders will not be allowed to ride without a person responsible signature. Juniors require the signature of a parent or guardian. There should be three (3) signatures on every entry form. You must use the ones attached to this prize list. If you are entering the WR and the EC Gold show, you must complete both forms.
- h. Cancellations prior to the August 6 closing date, entrants will have all fees, less the Administration fee, refunded. Cancellations after August 6 and prior to the ride times being published will forfeit all fees unless a veterinary certificate is provided then the class fee will be refunded. Once ride times are published no fees will be refunded.
- i. Show Office – Show Office will be open 1 hour before scheduled start of ride times, to 30 minutes after the last horse competes. The office will be open on Friday, 22, 2025, from 2:00 PM to 7:00 PM for check-in.
- j. Show correspondence will be handled through e-mail and Compete Easy. Ride times will be posted on the Compete Easy website as soon as they are available (no later than the Thursday before the show). Please provide the correct e-mail address on your entry form.
- k. In the event that the show is cancelled after Aug 6, 2025 due to extreme weather or other emergency situations (including but not limited to fire, biosecurity event), entrants will forfeit all fees.
- l. Should the facility be locked down due to an extended isolation or quarantine due to a biosecurity event, the cost of additional stabling, shavings and/or hay will be the responsibility of the entrant.

2. LIABILITY WAIVER

It is a condition of entry that the Edmonton Area Alberta Dressage Association, Organizing Committee, or Amberlea Meadows will not be held responsible in any way for damage, injury, or loss to persons, horses or property of spectators or competitors.

3. VOLUNTEERS

- a. The 2025 Edmonton Area Alberta Dressage Association encourages all our competitors to give back

through the act of volunteering. Volunteering for our Sparkle and Spurs AEF Wild Rose and EC Gold Dressage is beneficial for our entire community, because it creates friendships, boosts self-esteem, and fosters physical health." It also aligns with the True Sport Principle "Give Back."

- b. You can sign up to volunteer through Compete Easy. The volunteer positions available are, set up on August 21, tear down on August 23, and gate for August 23 and 24.
- c. EAADA members who volunteer 3 or more hours in 2025 at ADA events (any chapter) are eligible for 2025 EAADA Education and Clinic subsidies. The show is a great way to complete those hours. Other area groups have similar programs, so check them out.

4. WARM UP AND LUNGEING

Warm-up in the show rings is allowed on Friday 22 from 1:00 pm to 8:00 pm. Horses that are not stabled on the grounds may also haul in on Friday and school in the rings. On Saturday and Sunday, warm-up rings will be open for one hour before the start of classes each day and for one hour at the end of classes each day. Lungeing will be allowed in a designated area if space permits.

5. STABLING

- a. Show stalls are available from noon on Friday 22, 2025 (please **do not** arrive before this time) until the end of the Show on Sunday August 24, 2025. See Fee Schedule for prices.
- b. There is a limited amount of premium stabling in the main barn. It will be allocated on a first-entered basis.
- c. Two bags of shavings are included with each stall. Please pre-order extra bedding on your entry form.
- d. Horses must be put in assigned stalls only. No bedding may be removed from unoccupied stalls. No horse will be placed in an unassigned stall without approval from management. Stalls will be assigned at the sole discretion of the Organizing Committee. Note: Special requests (ex: stabling near someone) should be noted on the entry form and will be accommodated at the discretion of the Organizing Committee. Ask sooner rather than later.
- e. No smoking in the barn or hayshed.
- f. The stable area must always be kept clean and aisles unobstructed. Please deposit all manure and hay in manure bins.
- g. Absolutely no use of nails in Tack Stalls.
- h. All fans in the show barns must be unplugged by 9pm.

6. PARKING (VEHICLE/HORSE TRAILER/MOTORHOME)

- a. Motorhome parking with electrical plug-ins is available to the south of the arena (No unplugged, unpaid for units in this area). Due to limited power, electrical hook-ups directly at the Show Barn are not permitted.
- b. No motorhomes, trailers or vehicles with propane tanks may park within 50 feet of any building to avoid the risk of fire damage from a propane explosion.
- c. Parking is not allowed on any lawn areas.
- d. The fire lane (see facility map) must always be kept clear to allow for emergency vehicles in case of emergency.
- e. General parking for vehicles is available in front of the indoor arena or at the back on the north side of the show barn.
- f. Please be courteous when loading and unloading, DO NOT block the entrance to the show barn (west end) for any longer than necessary. You can also unload on the north side through the centre aisle.

7. WASH RACKS

Wash racks with cold running water are available on the east end of the show barn. There are wash racks in the main barn with hot and cold running water.

8. FOOD TRUCK

There will be a food truck on site on Saturday and Sunday.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW HORSE WELFARE

1. All participants shall be bound by the Horse Welfare Code of Conduct.
2. The inhumane treatment of an equine by any individual (competitor, owner, trainer, etc.) will not be tolerated anywhere on the grounds, under any circumstances.
3. Cruelty can be defined as intentionally causing pain or unnecessary discomfort to an equine. The standard by which such conduct will be measured is the determination of cruel, excessive, or inhumane treatment by a reasonable person who is informed and experienced in generally accepted equine training and procedures.
4. Anyone confirmed of abuse will be eliminated or disqualified and reported to the appropriate governing body.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW MEMBERSHIPS, LICENSES AND HORSE REGISTRATION

1. EC Gold Show

- a. An EC Gold Sport (or higher) license is required for both the competitor and horse owner, and an AEF membership (or other provincial body membership) is also required.
- b. Due to insurance regulations, all competitors must be a member of the Alberta Dressage Association (ADA). Competitors can become an ADA member by joining an area group, or by paying the one-time ADA show membership fee as outlined in the show fee schedule. The ADA show membership is only for insurance purposes at the Sparkle & Spurs Show and does not include any other membership privileges. If you are already an ADA member, please make sure to provide your area group affiliation membership number on the entry form. Information on the area chapters can be found on the ADA website <http://www.albertadressage.com>
- c. Please ensure you have completed the EC Concussion Awareness and Safe Sport training, or you will not be able to compete as EC will tag you as “not in good standing”.
- d. Adult Amateurs must be declared on their EC Sport license.
- e. The competitor or owner may pay a one-time show upgrading fee to compete at the Gold Show if they hold a valid EC Bronze or Silver license (EC A211.1). The one-time upgrade must be purchased on-line from EC.
- f. Canadian horses competing in the EC Gold Dressage Show are required to hold an EC Horse Recording and have paid the EC Horse Recording annual activation fee to compete (EC A602.4). Horse Recording number is the control number used by EC and must be included in the entry.
- g. Para-Dressage classes will be offered as part of the Sparkle and Spurs Gold Dressage Show. Athletes must submit copies of their EC Para-Dressage Dispensation Certificate and / or a copy of the EC Classification Master List with their entries and carry copies with them at all times while on the competition grounds (EC E 6.2.8).

2. AEF Wild Rose Dressage Show

- a. The competitor and horse owners require an AEF (or other provincial membership). EC Sport licenses and EC Horse Recordings are not required for the AEF Wild Rose Dressage Show.
- b. Due to insurance regulations, all competitors must be a member of the Alberta Dressage Association (ADA). Competitors can become an ADA member by joining an area group, or by paying the one-time ADA show membership fee as outlined in the show fee schedule. The ADA show membership is only

for insurance purposes at the Sparkle & Spurs Show and does not include any other membership privileges. If you are already an ADA member, please make sure to provide your area group affiliation membership number on the entry form. Information on the area chapters can be found on the ADA website <http://www.albertadressage.com>

EC GOLD SHOW and AEF WR PROVINCIAL CIRCUIT SHOW COACHING STATUS

1. EC Gold Show
 - a. When registering for the EC Gold Show, athletes must indicate the name of their coach on the entry form or specify that they are self-coached. Coaches from other countries, must be in good-standing with their home federation and must declare/have proof of insurance. (A102)
 - b. COACH STATUS REQUIREMENTS: All coaches at EC-sanctioned events require EC Licensed Coach Status. For upgrading from Registered to Licensed Status, coaches can apply for a Temporary Coach Status (TCS) to fulfill the requirements for each event. (EC A103.4). Temporary licenses must be purchased from EC in advance of the show.
 - c. EC Coaches are required to wear a lanyard indicating they are a coach. The lanyards can be picked up in the show office.
2. AEF WR Provincial Circuit Dressage Show

Starting January 1, 2025, coaching certification requirements will be implemented at provincial circuit competitions. The details are as follows:

 - a. Coaching Certification Requirements
 - i. NCCP Coaching Certification: All coaches must have NCCP Coaching certification.
 - b. Coaches without NCCP Coaching certification may still be eligible to coach if they meet one of the following criteria:
 - i. Hold an active EC Licensed Coach Status
 - ii. Hold an active International Group of Equestrian Qualifications (IGEQ) Passport
 - iii. Hold a Temporary Coach Badge for the specific competition
 - c. Coaches for the WR show are required to wear an AEF coaching badge. Details on obtaining a coaching badge can be found at www.albertaequestrian-events.com/coaching-wild-rose
 - d. When registering for the AEF WR Provincial Circuit Dressage Show, athletes must indicate the name of their coach on the entry form or specify that they are self-coached.

EC GOLD SHOW, and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW EQUINE VACCINATIONS

1. All horse entered in any class at a competition must have met the requirements of Article A519, Vaccination. See Rules of Equestrian Canada, Section A, General Regulations, Article A519, Vaccinations. (A602.8)
2. All horses attending the Sparkle and Spurs dressage shows must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not compliant with this rule may be asked to leave the event site at the discretion of Competition Management. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.
3. In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior

to arrival at the event site or during the event can be requested.

4. You must attach proof of vaccinations with your entry or the letter from a veterinarian as per item #3.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW AMBERLEA BIOSECURITY

BIOSECURITY Bio Security is everyone's responsibility!

Amberlea Meadows is committed to providing a safe and healthy environment for all exhibitors and their horses. All show participants are requested to practice good disease prevention practices. Travelling and showing horses are at an increased risk for spreading and contracting contagious diseases. To provide a safe environment, the following measures must be adhered to:

1. Entries that do not have proof of vaccinations (Influenza/EHV1-4) as per the Equine Vaccination Section of the prize list will not be accepted.
2. All horses entering the show grounds must not have been in contact with any sick horses within the last 14 days. They must not exhibit any sign of illness.
3. All horses coming on to the grounds must have a copy of valid Equine Influenza and EHV vaccinations (vaccinations must be administered within the last 6 months, but not within 7 days of arrival to the grounds). Proof of vaccination must be signed by a vet, on vet letterhead. The name on the vaccination **MUST MATCH** the name on the entry to be acceptable. Please have certificate records available upon request from Amberlea Meadows Staff.
4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns. The name on the letter **MUST MATCH** the name on the entry to be acceptable. Please have the letter available upon request from Amberlea Meadows Staff. Additionally, a log of temperatures taken twice daily for the seven days prior to entering the competition grounds must be available upon request from the Amberlea Staff.
5. All horses on the grounds must have their temperatures taken and recorded twice daily. Please have temperature records available upon request from Amberlea Meadows Staff.
6. Please avoid direct and/or indirect contact between horses, especially nose-to-nose contact.
7. **Competitors are required to notify the show office at the first sign of illness or elevated temperature. If the show office is closed, the show manager is to be contacted. The show organizers and Amberlea will enact the Bio Security Sick Horse Protocol to minimize the risk to other horses.**





EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW EQUINE MEDICATION CONTROL AND DRUG TESTING

1. Any horse entered in any class in the EC Gold Dressage Show or the AEF WR Provincial Circuit Dressage Show, may be selected for equine medication control testing while at the event location.
2. The EC medication Control Fee is listed in the show Fee Schedule. There is no AEF medication Control Fee.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW RULES

1. All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear including a chin strap (specified for equestrian sports) at all times when mounted. Protective headgear must be certified under one of the following standards: ASTM (American Society for Testing Materials)/SEI (Safety Equipment Institute, Inc.); BSI/BS EN (British Standards Institution); EN (European Union Standards); AS/NZS (Australian/New Zealand Standards); or CE VG1

01.040 2014-12 (provided they are BSI Kitemarked).

2. All competitors must report to the stewards immediately after their class is finished for a mandatory tack check. Athletes must report, still mounted, to the steward or his/her representative for a tack check immediately upon leaving the competition arena. The athlete may not remove any equipment or clothing before the steward has conducted his/her inspection. Exception: An athlete may, of course, dismount and remove their hat and jacket in the case of illness or feeling faint. A rider who is eliminated must still report to the steward.
3. Exhibitors must be ready to compete when scheduled.
4. It is compulsory for the horse's assigned competition number to be worn by the horse or rider/handler when the horse is outside the stall from the time that the number is issued until the end of the competition so that officials can identify the horse. Exception: Horses stabled permanently on the competition site are exempt unless competing. Failure to display this number will incur a warning for the first offence and, in the case of second or subsequent offences, possible elimination or disqualification at the discretion of the ground jury.
5. Any horse arriving on the competition grounds but not competing (i.e. not riding in a class) will be subject to all applicable rules and regulations and must be assigned a number that must be worn when the horse is outside the stall. Exception: Horses stabled permanently on the competition site are exempt unless they are competing.
6. Non-competing (Hors Concours) horses will be accepted to ride in a class.
 - a. Hors concours entries are not eligible for prizes, placings or awards.
 - b. Such entries must pay the full entry fee and are subject to all applicable rules and regulations.
 - c. A horse may be ridden both as an hors concours entry and a competitive entry at the same competition. The maximum number of tests ridden whether competitive or not is four/three per day including freestyle, depending on the Level showing
 - d. An hors concours entry in a freestyle must have qualified to ride the freestyle.
 - e. It does not matter in what order the hors concours and competitive tests are ridden as long as the horse/rider combination only competes in one category. No cross entering between Amateur/Junior and Open is allowed having ridden hors concours.
 - f. Hors concours entries are not permitted in championship competitions.
7. Horse substitutions are allowed until two hours before the class the horse is competing in provided the horse is eligible to enter. A change fee as stated in the Show Fee Schedule section will be charged. The name of the horse, any required licenses, and owner or person responsible signatures must be given to the show secretary at the time the substitution is made. Note: When qualifying criteria apply to a horse/athlete combination entered in a class, no substitution of horse or athlete may be made.
8. Rider substitutions are allowed until two hours before the class the horse is competing in provided the athlete is eligible to enter. A change fee as stated in the Show Fee Schedule section will be charged. The name of the athlete, any required licenses, and owner or person responsible signatures must be given to the show secretary at the time the substitution is made. Note: When qualifying criteria apply to a horse/athlete combination entered in a class, no substitution of horse or athlete may be made.
9. Class changes will be allowed at the discretion of the Organizing Committee, and if accepted, will be charged a change fee as stated in the Fee Schedule section.
10. Test readers are allowed for the Gold and Wild Rose classes, excluding FEI classes. You must provide your own reader.
11. Riders are responsible for providing their own numbers (i.e.: use their own bridle numbers).
12. Competitors are responsible for checking their ride times as they may change. Remember, your time is when you ride down centerline, not making your loop of the ring. The Organizing committee will keep changes to a minimum.
13. Open fires are not allowed on the grounds.

14. Photography. We have an official show photographer. If you wish to photo/video a specific ride, please be courteous to our official photographer and do not stand in front of them.
15. Do not ride or graze your horse on the front lawn.
16. Dogs must be kept on leash, please pick up after your dog.
17. Horses exhibiting heat stress are to be given priority to the wash bays for cooling purposes.
18. Hand sanitizers have been installed in the horse barns. Everyone entering or exiting the stabling areas must use hand sanitizers. Either those provided or their own.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW CLASSES

1. Maximum Tests:
 - a. A horse/athlete combination may compete in any two, but only two consecutive levels and a maximum of four tests per day including the freestyle for Introductory, Training and First levels, and three tests per day including the freestyle for Second; Third and Fourth levels and all FEI tests.
 - b. No horse may compete in more than four/three tests or rides combined per day, including the freestyle subject.
 - c. When more than one athlete competes on the same horse, the horse may not compete against itself and may not compete in more than four tests or rides per day including the freestyle if the tests or rides are First level or below and three tests or rides per day at Second level or above.
 - d. Equitation, Materiale and non-EC classes are included in the maximum of four classes per day at First level or below and three classes at Second level or above.

Note: When riding FEI tests in EC competitions, FEI Intermediate I and FEI Intermediate II tests are not consecutive levels. FEI Intermediate I is part of the small tour and Intermediate II is part of the Grand Prix division.
2. EC E7.8 EQUIVALENCIES – EC/FEI
 - a. All FEI Pony Rider and FEI Children's Tests are equivalent to Second Level
 - b. All FEI Junior Rider Tests are equivalent to Third Level
 - c. All FEI Young Rider Tests are equivalent to PSG
 - d. The FEI 4-Year-Old Test is equivalent to First Level
 - e. The FEI 5-Year-Old Test is equivalent to Second Level
 - f. The FEI 6-Year-Old Test is equivalent to Third Level
 - g. The FEI 7-Year-Old Tests are equivalent to Fourth Level
5. Masters Test of Choice (EC E Chapter 14) class will be offered as part of the EC Gold Dressage Show. The Masters Test of Choice Class is an EC dressage class that provides senior riders, 60 years and older, the opportunity to participate in a dressage class that is exclusively their own that provides a fair playing field for senior riders wherein each will compete against their peers at all levels of skill, from beginners to advanced. The class will feature one test per day – please identify which test on your entry. Please review EC rules for the list of accommodations available. Masters riders may also compete in non-Masters dressage classes.
6. The AEF Wild Rose Provincial Circuit Show will offer EC dressage tests, FEI Freestyles, FEI classes, FEI Para Dressage Tests, and Canada Pony Club tests . The AEF Wild Rose Provincial Circuit Show classes are not rated for EC awards.
7. The EC Gold and WR Provincial Circuit Show will offer a fun class called Hoofin' It as part of the Footloose and Freestyles social on Saturday after the freestyles. The Hoofin' It class is not rated for EC awards.

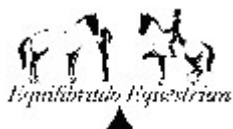

EC GOLD SHOW and AEF WR PROVINCIAL CIRCUIT SHOW FREESTYLES

1. The athlete must provide the show organizer with a functioning copy of their freestyle music on a USB stick **OR** email your music to showsecretary.eaada@gmail.com with rider name, name of horse, and level of freestyle. If emailing please do so ahead of time (send before 9pm on Thursday August 21, 2025) and confirm with the show organizer that they have your music. If providing a USB, please give to show organizer at check-in.
2. Competitors are responsible for doing a sound check with the announcer Saturday at noon.
3. Freestyle eligibility for riders in EC Gold Show: A horse/rider combination must have obtained the following prior to competing in a freestyle: A minimum score of 60% in a dressage test at the same technical level, or higher, as the freestyle they wish to enter (e.g. 60% in First or Second Level to compete in the First and/or Second Level Freestyle). The dressage score may have been obtained at an EC Gold/Silver dressage competition prior to the competition, or may be obtained at the same competition in which they wish to enter the freestyle.
4. A qualifying score is not required for the AEF WR Provincial Circuit Show.
5. Your EC Gold Show Freestyle score can be used for the EC Gold Freestyle Championship, provided a technical test is ridden as well.
6. A technical score is not required for the AEF WR Provincial Circuit Show.

EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW PRIZES AND AWARD INFORMATION

1. Prize money will be paid out as per EC A701.
2. The AEF Wild Rose Provincial Circuit Show and the Hoofin'It class are not rated for EC awards.
3. Class ribbons for the EC Gold and AEF Wild Rose Provincial Circuit classes will be distributed at the show office. Class ribbons will be given to 6th place by category of rider (Open, Amateur, Junior).
4. The organizing committee has the authority to combine divisions (O, JR, AA) within a class if less than 3 entries.
5. Any horse receiving less than 50% of the total points obtainable in a test shall not be eligible for awards, ribbons, or prizes.
6. When there is only one horse in a class, ribbons and prizes shall be awarded in accordance with the following chart of percentages:

- 1st: 63% or higher,
- 2nd: 60% to 62.9%,
- 3rd: 58% to 59.9.

No ribbons or prizes shall be awarded below 3rd position.

7. Ties for Class Placings:
 - a. In the case of equality of points the competitor with the highest total of collective marks shall be declared the winner. When collective marks are tied, the horses shall remain tied.
 - b. In the case of an unbreakable tie each horse will remain tied. For example, if three horses were tied for second place, each would receive second place. The next placed horse would receive fifth place.

No Young horse tests. Competitors are considered a Junior if they are 18 years of age or less or, if they have turned 18 during the current competition season, they may still compete as a junior rider.

Jan was instrumental in the development of the Alberta Dressage Association. She was president of ADA for many years and a past chairperson of the ADA's annual casino fundraiser. She is also a cherished past president of the EAADA and could always be found doing multiple volunteer tasks at Edmonton dressage shows, often scribing and preparing gift baskets for the judges. She orchestrated the club's merchandising program and, with her artistic skills, created the beautiful EAADA logo which remains a proud symbol that embodies the love Jan has for the club, and the sport she loves. She also contributed to the EAADA Newsletter and the organization of educational sessions.

She was awarded an EAADA "Lifetime Membership" for her dedication to the sport of dressage and the area group. Jan embodies the true spirit of volunteerism. Nationally, Jan managed group memberships for USDF for interested dressage people. Jan was honored by being chosen the Equestrian Canada Dressage Volunteer of the Month for June 2017. A Personal Note: Jan is also a dedicated horsewoman. In December 2016 she lost Sky, her beloved equine partner of 36 years.

**b. EAADA Award for Adult Amateurs in Memory of Karen Harries
\$500 Prize sponsored by Wilma Jackson**



Criteria: Awarded by the EAADA for the highest average of 2 scores for an Adult Amateur rider from the Sparkle & Spurs Gold Show. Scores must be from the same level and must be technical tests only. No Young horse tests.

Competitors must have the Adult Amateur designation on their Equestrian Canada Sports License to be eligible.

Karen Duncan Harries (November 16, 1953 – November 7, 2013)

Karen was born in Edmonton. In the '70s while Karen was teaching in Quebec, she decided to take riding lessons along with a friend. That triggered her lasting enthusiasm for riding. She returned to Edmonton where she taught in junior and senior high schools and began to take riding lessons at Amberlea Meadows on lesson horses.

Karen became active in the dressage world, helping with the organizing of clinics and shows, writing as a scribe for the judges, and serving for several years on the EA/ADA executive. She continued to ride horses that, where available, took lessons, and attended clinics.

Karen became a horse owner. She loved riding – it gave her the exercise she needed and freedom from the cares and stresses of life beyond the horse world. Her horses were willing and kind but unfortunately each one developed medical issues.

In 2013, while riding her own new mare, Karen succumbed to injuries sustained while enjoying her favorite pastime.

c. EAADA Open Award in Memory of Colin Crone - \$125 Prize



Criteria: Awarded by EAADA for the highest average of 2 scores for an Open rider from the Sparkle & Spurs Gold Show. Scores must be from the same level and must be technical tests only. No Young horse tests.

Colin Crone (July 1, 1933 – July 3, 2008)

In 1988, Colin bought Killerney Farms (formerly Tom Budd's, Abbey Stables and Hubbard Stables) and combined the stable and his construction company into Killerney Group.

Shortly afterwards, Colin entered the dressage scene, donating his facility for his first EAADA Wild Rose Schooling Show on July 7, 1990, (20 horses entered) and he continued to do so almost every year until 2008. In December 1990, he reported to the EAADA executive the progress of meetings planning the fate of the Whitemud Equine Centre. In 1991 he put on his first Killerney Stables Dressage Show.

Colin made a lasting impact with our dressage community and that is why the Edmonton Area Alberta Dressage Association continues to honor his memory and dedication to the sport of dressage.

d. EAADA FEI Para Dressage Award – \$125 Prize

Criteria: Awarded by the EAADA for the highest average of 2 scores for a FEI para dressage rider from the Sparkle & Spurs EC Gold Show. Scores must be from the same level and must be technical tests only.

BIOSECURITY REQUIREMENT

see Amberlea Biosecurity Section of the prize list for full details.

You must take and log the temperature of your horse twice a day while on the show grounds.

You must provide a copy of the log when requested.

You must have a copy of your vaccine certificate or exemption letter.

You must provide a copy of the certificate or letter when requested.

Horses that have exemption letters must provide a log of temperatures for the 7 days prior to the show when requested.

You must report any horse with an elevated temperature to the show office. If the show office is closed, contact the Show Manager. The show organizers and Amberlea will enact the Bio Security – Sick Horse Protocol.

HEAT STRESS IN EQUINES

The most important means of dissipating heat for a horse is the evaporation of sweat. Therefore, humidity can become a more significant consideration than temperature.

Prevention of heat stress/stroke:

- Pre-cool equines by hosing them to lower demands on the equine's cooling systems while they work.
- Abbreviate warm-up times.
- After exercise, cool the equine by hosing with cold water, place in shaded area, use fans on the equine,
- Encourage hydration of the equine with cool, clean water and electrolytes.

Signs of equine heat stress/stroke may include the following:

- High Temperature 41-43C (105-107F)
- Rapid breathing/rapid pulse
- Stumbling, weakness, depression
- Refusal to eat or work
- Dry skin and dehydration.
- In severe cases, an equine may collapse or go into convulsions or a coma

Treatment for heat stress/stroke:

- Call a veterinarian
- Run cold water over the entire body of the equine. May need to be hosed with 2 hoses for 20 to minutes.
- Place the equine in the shade, preferably in a grassy area and not on pavement or dark-coloured ground.
- If there is no breeze, use a fan
- Allow the equine to drink water to offset dehydration.
- Electrolytes may also be given orally.

AIR QUALITY AND EQUINES

Competitors should monitor their equines closely and retire from competition if symptoms of respiratory distress occur. This is particularly competitors with high-risk equines. High-risk equines include older and younger equines and equines with pre-existing respiratory conditions.

Common Signs of Respiratory Distress

- Respiratory rate remaining over 30 breaths per minute at rest (normal rate is 12-20 per minute).
- Shortness of breath with possible wheezing sounds.
- Nostrils obviously flaring and anxious expression.
- Very labored breathing with exaggerated movement of chest wall and flanks.
- Possible repetitive, deep cough.
- Possible nasal discharge.

Call the on-call vet if you suspect an equine is experiencing respiratory distress. Or their own vet.

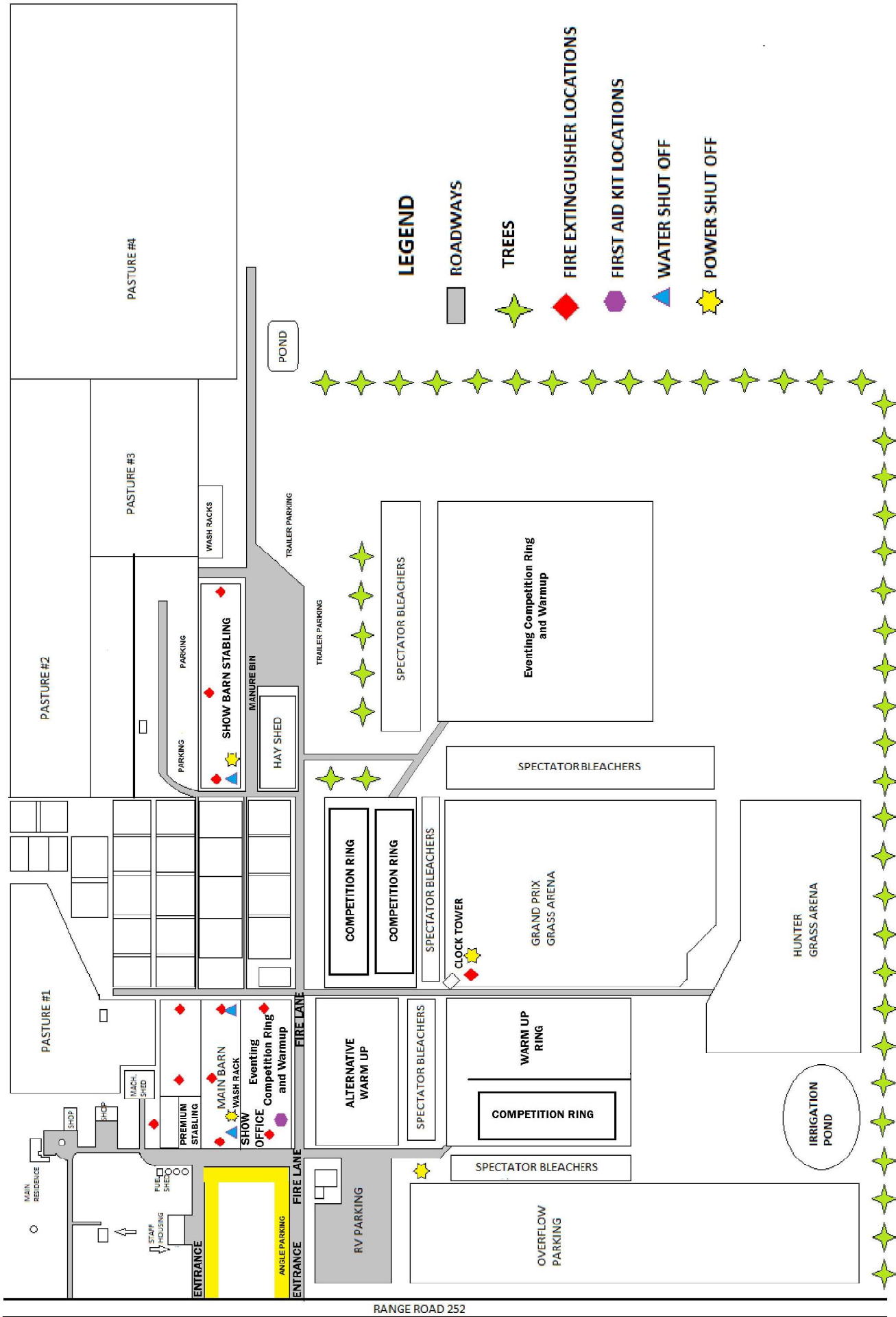

AEF GENERAL INFORMATION

1. The 2025 Sparkle & Spurs AEF Wild Rose Schooling Show is sanctioned as an Alberta Equestrian Federation Wild Rose schooling competition of Alberta Equestrian Federation and will be run in accordance to the AEF Wild Rose Competition Rulebook.
2. Every class offered herein is covered by the rules and specifications of the current Wild Rose Competition Rulebook and will be held and judged in accordance with the Rulebook. It is the rider's responsibility to be familiar with the AEF rules and regulations. They can be found at <https://www.albertaequestrian-events.com/competitions>
3. Every participant at the AEF Wild Rose Competition shall agree that the owner, lessee, trainer, manager, agent, coach, driver or rider, and horse shall be subject to the constitution and rules of the competition. Not all the AEF Rules are listed in the prize list. It is the responsibility of all to know the AEF rules.
4. The competition is required to ensure all athletes, owners, lessees and person(s) responsible for an entry hold a current AEF membership to ensure each entry is protected by their own individual liability coverage. Exceptions: Out-Of-Province competitors are not required to hold AEF membership provided they are members of their respective PTSO and are in good standing. A parent or guardian are not required to have an AEF membership if signing as the person(s) responsible for an entry that is a minor/junior competitor.

GENERAL INFORMATION

1. ENTRIES & SHOW OFFICE

- a. Entries must be received no later than August 6, 2025, with full payment and signed forms.
- b. There are two ways to enter the show:
 - i. Compete Easy is the show management system for the Sparkle & Spurs show. Compete Easy charges a 5.5% processing fee that will be applied to your EAADA Sparkle & Spurs entry fee. To enter, please visit: www.competeeasy.com and then go to the SHOW section. The show will be live for entries July 18, 2025.
 - ii. If you still wish to mail / email your entry in, you will be charged a mandatory processing fee. See the Fee Schedule for the cost. Scan and email your entry to showsecretary.eaada@gmail.com and pay by email bank transfer, also to showsecretary.eaada@gmail.com. The password for the email bank transfer should be set to dressage.
- c. If there are any questions about entries, please email showsecretary.eaada@gmail.com.
- d. Late entries may only be accepted at the Organizing Committee's discretion with a late fee as set out in the Fee Schedule.
- e. Entries may be limited and will be processed in the order that they are received. The Organizing Committee reserves the right to refuse entries.
- f. Incomplete entries will not be processed until they are complete. All entries must include payment in full, all release signatures and copies of vaccination certificate.
- g. All entries must have the signature of the owner or authorized agent and the signature of the person responsible for the horse. Riders will not be allowed to ride without a person responsible signature. Juniors require the signature of a parent or guardian. There should be three (3) signatures on every entry form. You must use the ones attached to this prize list.
- h. Cancellations prior to the August 6 closing date, entrants will have all fees, less the Administration fee, refunded. Cancellations after August 6 and prior to the ride times being published will forfeit all fees unless a veterinary certificate is provided then the class fee will be refunded. Once ride times are published no fees will be refunded.
- i. Show Office – Show Office will be open 1 hour before scheduled start of ride times, to 30 minutes after the last horse competes. The office will be open on Friday, 22, 2025, from 2:00 PM to 7:00 PM for check-in.
- j. Show correspondence will be handled through e-mail and Compete Easy. Ride times will be posted on the Compete Easy website as soon as they are available (no later than the Thursday before the show). Please provide the correct e-mail address on your entry form.
- k. In the event that the show is cancelled after Aug 6, 2025 due to extreme weather or other emergency situations (including but not limited to fire, biosecurity event), entrants will forfeit all fees.
- l. Should the facility be locked down due to an extended isolation or quarantine due to a biosecurity event, the cost of additional stabling, shavings and/or hay will be the responsibility of the entrant.

2. LIABILITY WAIVER

It is a condition of entry that the Edmonton Area Alberta Dressage Association, Organizing Committee, the Canadian Eventing Development Foundation, or Amberlea Meadows will not be held responsible in any way for damage, injury, or loss to persons, horses or property of spectators or competitors.

3. VOLUNTEERS

- a. The Edmonton Area Alberta Dressage Association and the Canadian Eventing Development Foundation encourages all our competitors to give back through the act of volunteering. Volunteering for our Sparkle and Spurs AEF Wild Rose Schooling Show is beneficial for our entire community, because it creates friendships, boosts self-esteem, and fosters physical health." It also aligns with the True Sport Principle "Give Back."
- b. You can sign up to volunteer through Compete Easy.

- c. EAADA members who volunteer 3 or more hours in 2025 at ADA events (any chapter) are eligible for 2025 EAADA Education and Clinic subsidies. The show is a great way to complete those hours. Other area groups have similar programs, so check them out.

4. WARM UP AND LUNGEING

Warm-up in the show rings is allowed on Friday 22 from 1:00 pm to 6:00 pm. Horses that are not stabled on the grounds may also haul in on Friday and school in the rings. On Saturday and Sunday, warm-up rings will be open for one hour before the start of classes each day and for one hour at the end of classes each day. Lungeing will be allowed in a designated area if space permits.

5. STABLING

- a. Show stalls are available from noon on Friday 22, 2025 (please **do not** arrive before this time) until the end of the Show on Sunday August 24, 2025. See Fee Schedule for prices.
- b. Two bags of shavings are included with each stall. Please pre-order extra bedding on your entry form.
- c. Horses must be put in assigned stalls only. No bedding may be removed from unoccupied stalls. No horse will be placed in an unassigned stall without approval from management. Stalls will be assigned at the sole discretion of the Organizing Committee. Note: Special requests (ex: stabling near someone) should be noted on the entry form and will be accommodated at the discretion of the Organizing Committee. Ask sooner rather than later.
- d. No smoking in the barn or hayshed.
- e. The stable area must always be kept clean and aisles unobstructed. Please deposit all manure and hay in manure bins.
- f. Absolutely no use of nails in Tack Stalls.
- g. All fans in the show barns must be unplugged by 9pm.

6. PARKING (VEHICLE/HORSE TRAILER/MOTORHOME)

- a. Motorhome parking with electrical plug-ins is available to the south of the arena (No unplugged, unpaid for units in this area). Due to limited power, electrical hook-ups directly at the Show Barn are not permitted.
- b. No motorhomes, trailers or vehicles with propane tanks may park within 50 feet of any building to avoid the risk of fire damage from a propane explosion.
- c. Parking is not allowed on any lawn areas.
- d. The fire lane (see facility map) must always be kept clear to allow for emergency vehicles in case of emergency.
- e. General parking for vehicles is available in front of the indoor arena or at the back on the north side of the show barn.
- f. Please be courteous when loading and unloading, DO NOT block the entrance to the show barn (west end) for any longer than necessary. You can also unload on the north side through the centre aisle.

7. WASH RACKS

Wash racks with cold running water are available on the east end of the show barn. There are wash racks in the main barn with hot and cold running water.

8. FOOD TRUCK

There will be a food truck on site on Saturday and Sunday.

AEF WILD ROSE SCHOOLING SHOW HORSE WELFARE

1. All participants shall be bound by the Horse Welfare Code of Conduct.
2. The inhumane treatment of an equine by any individual (competitor, owner, trainer, etc.) will not be tolerated anywhere on the grounds, under any circumstances.
3. Cruelty can be defined as intentionally causing pain or unnecessary discomfort to an equine. The standard by which such conduct will be measured is the determination of cruel, excessive, or inhumane treatment by a reasonable person who is informed and experienced in generally accepted equine training and procedures.

4. Anyone confirmed of abuse will be eliminated or disqualified and reported to the appropriate governing body.

AEF WILD ROSE SCHOOLING SHOW MEMBERSHIPS, LICENSES AND HORSE REGISTRATION

1. The competitor and horse owners require an AEF (or other provincial membership).
2. Due to insurance regulations, all competitors must be a member of the Alberta Dressage Association (ADA). Competitors can become an ADA member by joining an area group, or by paying the one-time ADA show membership fee as outlined in the show fee schedule. The ADA show membership is only for insurance purposes at the Sparkle & Spurs Show and does not include any other membership privileges. If you are already an ADA member, please make sure to provide your area group affiliation membership number on the entry form. Information on the area chapters can be found on the ADA website.

AEF WR SCHOOLING SHOW COACHING

1. Coaches are not required to have certification or a license for the AEF Wild Rose Schooling Show.
2. Entrants must list their coach on the entry form.
3. Coaches will be required to wear a lanyard identifying them as AEF WR Schooling Show Coaches. The lanyards can be picked up at the show office.

AEF WILD ROSE SCHOOLING SHOW EQUINE VACCINATIONS

1. All horses attending the Sparkle and Spurs shows must have been administered Equine Influenza and Equine Herpes Virus (1&4) vaccinations within 6 months (+21 days grace period) before arrival at the event. No horse shall receive vaccination within 7 days prior to arrival at the event. Horses not compliant with this rule may be asked to leave the event site at the discretion of Competition Management. Competition management may request supporting documentation confirming a horse's compliance with mandatory vaccination requirements.
2. In the case of a horse that is unable to receive either of the vaccines, a letter from a veterinarian on official letterhead must be provided with the entry form, stating the horse cannot be vaccinated due to medical concerns. At the discretion of competition management, a log of the horse's temperature prior to arrival at the event site or during the event can be requested.
3. You must attach proof of vaccinations with your entry or the letter from a veterinarian as per item #2.

AEF WILD ROSE SCHOOLING SHOW AMBERLEA BIOSECURITY

BIOSECURITY Bio Security is everyone's responsibility!

Amberlea Meadows is committed to providing a safe and healthy environment for all exhibitors and their horses. All show participants are requested to practice good disease prevention practices. Travelling and showing horses are at an increased risk for spreading and contracting contagious diseases. To provide a safe environment, the following measures must be adhered to:

1. Entries that do not have proof of vaccinations (Influenza/EHV1-4) as per the Equine Vaccination Section of the prize list will not be accepted.

2. All horses entering the show grounds must not have been in contact with any sick horses within the last 14 days. They must not exhibit any sign of illness.
3. All horses coming on to the grounds must have a copy of valid Equine Influenza and EHV vaccinations (vaccinations must be administered within the last 6 months, but not within 7 days of arrival to the grounds). Proof of vaccination must be signed by a vet, on vet letterhead. The name on the vaccination MUST MATCH the name on the entry to be acceptable. Please have certificate records available upon request from Amberlea Meadows Staff.
4. In the case of a horse that is unable to receive either of the vaccinations due to a history of adverse reactions, the exhibitor must provide a letter from the veterinarian on official letterhead stating that the horse in question cannot be vaccinated due to medical concerns. The name on the letter MUST MATCH the name on the entry to be acceptable. Please have the letter available upon request from Amberlea Meadows Staff. Additionally, a log of temperatures taken twice daily for the seven days prior to entering the competition grounds must be available upon request from the Amberlea Staff.
5. All horses on the grounds must have their temperatures taken and recorded twice daily. Please have temperature records available upon request from Amberlea Meadows Staff.
6. Please avoid direct and/or indirect contact between horses, especially nose-to-nose contact.
7. **Competitors are required to notify the show office at the first sign of illness or elevated temperature. If the show office is closed, the show manager is to be contacted. The show organizers and Amberlea will enact the Bio Security Sick Horse Protocol to minimize the risk to other horses.**





EC GOLD SHOW and AEF WILD ROSE PROVINCIAL CIRCUIT SHOW EQUINE MEDICATION CONTROL AND DRUG TESTING

1. Any horse entered in any class in the AEF Wild Rose Schooling Show, may be selected for equine medication control testing while at the event location.
2. There is no AEF medication Control Fee.

AEF WILD ROSE SCHOOLING SHOW RULES

1. All athletes, regardless of age or level of competition, must wear properly fitted and fastened safety approved protective headgear including a chin strap (specified for equestrian sports) at all times when mounted. Protective headgear must be certified under one of the following standards: ASTM (American Society for Testing Materials)/SEI (Safety Equipment Institute, Inc.); BSI/BS EN (British Standards Institution); EN (European Union Standards); AS/NZS

(Australian/New Zealand Standards); or CE VG1 01.040 2014-12 (provided they are BSI Kitemarked).

2. Exhibitors must be ready to compete when scheduled.
3. It is compulsory for the horse's assigned competition number to be worn by the horse or rider/handler when the horse is outside the stall from the time that the number is issued until the end of the competition so that officials can identify the horse. Exception: Horses stabled permanently on the competition site are exempt unless competing. Failure to display this number will incur a warning for the first offence and, in the case of second or subsequent offences, possible elimination or disqualification at the discretion of the ground jury.
4. Test readers are allowed. You must provide your own reader.
5. Riders are responsible for providing their own numbers (i.e.: use their own bridle numbers).
6. Competitors are responsible for checking their ride times as they may change.
7. Open fires are not allowed on the grounds.
8. Photography. We have an official show photographer. If you wish to photo/video a specific ride, please be courteous to our official photographer and do not stand in front of them.
9. Do not ride or graze your horse on the front lawn.
10. Dogs must be kept on leash, please pick up after your dog.
11. Horses exhibiting heat stress are to be given priority to the wash bays for cooling purposes.
12. Hand sanitizers have been installed in the horse barns. Everyone entering or exiting the stabling areas must use hand sanitizers. Either those provided or their own.

AEF WILD ROSE SCHOOLING SHOW CLASSES

1. Maximum Tests:
 - a. A horse/athlete combination may compete in four tests per day for national levels, and three tests per day for all FEI tests.
 - b. No horse may compete in more than four/three tests or rides combined per day.
 - c. When more than one athlete competes on the same horse, the horse may not compete against itself and may not compete in more than four tests or rides per day.
 - d. The AEF Combined test classes count as 2 classes (1 Dressage, 1 Jumping).
2. Wild Rose Schooling Show will offer Eventing Dressage, Eventing Combined, and Showjump Rounds.
3. The AEF WR Schooling Show will offer a fun class called Hoofin' It as part of the Footloose and Freestyles social on Saturday after the freestyles.

AEF WILD ROSE SCHOOLING SHOW

PRIZES AND AWARD INFORMATION

1. Class ribbons for the AEF Wild Rose Schooling Show Dressage Eventing will be distributed in the show office. The combined tests will be presented at ring side. Class ribbons will be given to 6th place.
2. When there is only one horse in a dressage eventing class, ribbons and prizes shall be awarded in accordance with the following chart of percentages:
 1st: 63% or higher,
 2nd: 60% to 62.9%,
 3rd: 58% to 59.9.
 No ribbons or prizes shall be awarded below 3rd position.
3. Ties for Class Placings:
 - a. In the case of equality of points the competitor with the highest total of collective marks shall be declared the winner. When collective marks are tied, the horses shall remain tied.
 - b. In the case of an unbreakable tie each horse will remain tied. For example, if three horses were tied for second place, each would receive second place. The next placed horse would receive fifth place.

ShowJump Rounds – Sunday, August 24

Jump rounds will follow standard jumper rules, including elimination for refusals, off-course errors, or falls. Heights will begin at the lowest level and increase progressively throughout the day, as warranted by entries.

Jump rounds will run in conjunction with the Combined Tests on Sunday. Riders may enter additional jump rounds in addition to their Combined Test entry. These rounds offer an opportunity to practice the course ahead of your Combined Test.

- Riders may enter jump rounds at:
- The same height as their Combined Test
- A lower height
- A higher height

Please note the following:

- Classes will run from **Highest to lowest height**.
- If you enter a jump round at a **lower height** than your Combined Test, it will take place **after** your Combined Test round.
- If you enter a jump round at a **higher height**, it will take place **before** your Combined Test round.

This flexible format allows riders to prepare at the height of their choice while maintaining the overall flow and fairness of competition.

Note: Per EC Rules, each horse may enter up to a maximum of 4 classes (including dressage or jumping classes) total per day. Combined tests count as 2 classes (1 Dressage, 1 Jumping).

Combined Test – Dressage and ShowJumping Competition – Sunday, August 24

A **Combined Test** is a fun and approachable way for riders to gain experience in two phases of Eventing — **Dressage** and **ShowJumping** — without the cross-country portion.

- **Dressage Test Portion:** Begins at 8:00 AM, starting with the lowest levels and will continue progressively through the levels.
- **ShowJumping Test Portion:** Takes place at least 1 hour after each rider's dressage test. Jumping will take place on the large grass ring and will be a full course.

How it works:

- Dressage is scored in **penalty points** (lower is better!).
- Show jumping penalties (such as **knocked rails**, **refusals**, or **time faults**) are added to the dressage score.
- 🏆 The rider with the **lowest combined score** wins their division!

BIOSECURITY REQUIREMENT

see Amberlea Biosecurity Section of the prize list for full details.

You must take and log the temperature of your horse twice a day while on the show grounds.

You must provide a copy of the log when requested.

You must have a copy of your vaccine certificate or exemption letter.

You must provide a copy of the certificate or letter when requested.

Horses that have exemption letters must provide a log of temperatures for the 7 days prior to the show when requested.

You must report any horse with an elevated temperature to the show office. If the show office is closed, contact the Show Manager. The show organizers and Amberlea will enact the Bio Security – Sick Horse Protocol.

Heat Stress in Equines

The most important means of dissipating heat for a horse is the evaporation of sweat. Therefore, humidity can become a more significant consideration than temperature.

Prevention of heat stress/stroke:

- Pre-cool equines by hosing them to lower demands on the equine's cooling systems while they work.
- Abbreviate warm-up times.
- After exercise, cool the equine by hosing with cold water, place in shaded area, use fans on the equine,
- Encourage hydration of the equine with cool, clean water and electrolytes.

Signs of equine heat stress/stroke may include the following:

- High Temperature 41-43C (105-107F)
- Rapid breathing/rapid pulse
- Stumbling, weakness, depression
- Refusal to eat or work
- Dry skin and dehydration.
- In severe cases, an equine may collapse or go into convulsions or a coma

Treatment for heat stress/stroke:

- Call a veterinarian
- Run cold water over the entire body of the equine. May need to be hosed with 2 hoses for 20 to minutes.
- Place the equine in the shade, preferably in a grassy area and not on pavement or dark-coloured ground.
- If there is no breeze, use a fan
- Allow the equine to drink water to offset dehydration.
- Electrolytes may also be given orally.

Air Quality and Equines

Competitors should monitor their equines closely and retire from competition if symptoms of respiratory distress occur. This is particularly competitors with high-risk equines. High-risk equines include older and younger equines and equines with pre-existing respiratory conditions.

Common Signs of Respiratory Distress

- Respiratory rate remaining over 30 breaths per minute at rest (normal rate is 12-20 per minute).
- Shortness of breath with possible wheezing sounds.
- Nostrils obviously flaring and anxious expression.
- Very labored breathing with exaggerated movement of chest wall and flanks.
- Possible repetitive, deep cough.
- Possible nasal discharge.

Call the on-call vet if you suspect an equine is experiencing respiratory distress. Or their own vet.
